# PROCESS FOR VIBRATIONAL SELECTION Sahaja yoga Australia

The principles were approved by HH Shri Mataji at Genoa in 2010



The method used is designed to give a fully transparent recorded process for selecting HH Shri Mataji's representatives as Coordinators, Councillors and Trustees utilising Divine Vibrations as indicated by Her Holiness through chosen 'Selectors / Checkers'.

# AUTHORISED FACILITATORS

The Trust and the Council will each nominate two respected Senior Yogi / Yogini who will be appointed as 'Facilitators' to arrange all required resources and conduct both the 'Selector / Checker' process and the Councillor / Coordinator / Trustee Selection process.

The established delegated and approved Facilitators Team will conduct the selections. The current Coordinator, Councillors or Trustees will not be involved.

The Facilitators will all read and become familiar with these guidelines and prepare all required resources.

# STAGE 1 - CHOOSING SELECTORS

Provide five A4 coloured 'Manila' envelopes with numbers 1 to 5 (numbers provided in the package) on them. Two photos of Her Holiness approximately A4 size are placed into two separate envelopes (provided by the Facilitators). The remaining three envelopes have an A4 page with negative words such as 'Lust', 'Hatred', 'Anger'. (Words are provided).

Assembled Yogis are provided with pens and the form with five squares and are asked to check vibrations of each A4 envelope, one at a time and presented separately. The yogis are given sufficient time to check the vibrations of each envelope. The Yogi then marks the numbered squares with a tick or cross if they feel vibrations from the corresponding envelope.

The forms with the five boxes marked by yogis are collected from everyone to be carefully checked by Facilitators to see who is more accurately feeling Mother's vibrations on the day. After the forms are collected the A4 envelopes are opened to show yogis present the contents which are replaced in the same numbered envelopes.

Those with the most correct answers (Checkers) will be notified and asked to take part in the Stage 3 selection checking in a private place. Minimum three Checkers are required.

#### **Stage 2 - SELECTING CANDIDATES**

The process ensures vibration checking is carried out in a completely anonymous situation where candidates' names (*see appendix 'Criteria for Candidates'*) are placed inside sealed envelopes with only a number displayed on the outside.

#### Nominations for positions.

The Nomination Process will be conducted by delegated 'Selection Facilitators' with public announcements using an online registration program. Nominees will need to provide a referee and meet a Selection Criteria which will be provided. All nomination records are to be included with the Stage 1 and 2 Selection Documents and stored at HH Shri Mataji's Burwood Centre. All nominees will be advised of the outcome of the Selection processes.

For:

**State Councillors:** The Selection Facilitators will seek self nominations for positions for each state. **National Councillors:** Nominees are required to have gained previous experience as recent State or National Councillors.

**National Coordinator:** Nominations will be overseen by the Australian Council and Trustees with nominees checked on vibrations as with all other positions.

**Trustees:** Nominations will need to provide CV's and meet Specific Selection criteria to ensure capability within the Trust.

#### **Stage 3 - VIBRATIONAL SELECTION**

The Facilitators will arrange for all candidates' names to be printed off in a LARGE FONT (*no handwriting anywhere to avoid writers' vibrations*) to be placed in DL size 'manila' non-transparent sealed envelopes. The envelopes are shuffled by a separate assistant not present when the names were placed and will glue numbers to the outside of the envelopes. Thus, no-one will know which names are in the numbered envelopes.

The 'Selectors / Checkers' will spend some time in Meditation and then each numbered envelope will be presented on a music stand or similar and checked on vibrations with the question: "Shri Mataji, is it Your Will that this Yogi/Yogini be a NATIONAL or STATE COUNCILLOR or COORDINATOR or TRUSTEE." COOL requires both hands to be cool with no catches. Any catches will be recorded as NOT COOL.

Using the 'Selection of Nominees on Vibrations Form' all indicated vibrations are to be marked on the Form against the appropriate number. Checkers remain in place and in meditation in case a further check is required and will only be rechecked before any envelopes are opened. When all the checking is complete the Facilitators will take the completed forms and open the envelopes and place the names on the sheets next to the envelope number.

#### **IMPORTANT**

Once the names have been placed on the forms they are to be immediately replaced back into THE SAME NUMBERED ENVELOPES and sealed.

#### COMPILATION LIST

A list is then made up of all Candidates with the vibration indications for each person noted under their names.

A summation of results will be added to the 'Results Form.' Eg: Which Candidate received most Cool results. Which Candidate received most Not Cool results. Details of catches. Final Results to be listed on the Results form 1,2,3 and so on.

The current National Coordinator and Trustees are to be provided with a copy of the Results List by email with all information to remain confidential.

## CHECKING ACCEPTANCE

When new Councillors or Trustees are selected, either the Coordinator or Trustee will contact the selected candidate/s to ensure they will accept the delegated position. If not, the next in line candidate is to be approached. All Trustees are to be included in all communications.

When all arrangements have been completed a letter will be composed to Her Holiness by the Coordinator / Trustees advising the selection of Her new Councillors/Coordinator/Trustee and sent to Nirmal Dham. After a few days the announcement will be made to the Collective.

## **RECORD KEEPING**

All of the original envelopes, forms and any records are to be securely retained by the Facilitators during the process.

Once the process is completed all records are to be placed in an A4 or larger envelope marked "Councillor/Coordinator/Trustee Selection (date) (State)" and placed in our secure filing system in HH Shri Mataji's rooms at Burwood.

Any Sahaja Yogis wishing to view the records held at Burwood will need to apply to the Coordinator or Trustees providing a reason and do the viewing in the company of one of the Trustees.

Details of any catches or other private information from the Selection Process are never to be discussed with anyone. Apart from the original records any copies or photos of confidential information are to be deleted or destroyed.

A new Councillor/Coordinator/Trustee is only considered selected after fully complying and with proof of fulfilling all the processes in these documents.

# SEPERATION OF DUTY AND RECORD KEEPING DUTIES OF THE FACILITATORS

To ensure no perception of interference Facilitators cannot be a Coordinator, Councillor or Trustee and they will have no role in the process once arrangements are made and handed over to the Facilitators.

Adequate printed copies of the '5 square' forms used to choose the 'Selectors / Checkers.'

**Numbers 1 to 5** (provided in package) to be printed and glued on outside of five A4 Manila envelopes with 3 Negative words (provided in package)

**Two approximately A4 size photos of Shri Mataji** (provided by Facilitators) to go inside separate A4 envelopes along with negative words in separate envelopes for choosing 'Selectors / Checkers'.

**All required Vibration Selection Forms** will be provided to the Selection Management Team. All Records are to remain sealed and delivered to Her Holiness at Burwood. Interstate records are to be sent by secure delivery to a designated NSW Trustee to deliver to Burwood.

# LOCATION

To maximise participation numbers all Trust, Councillor and National Coordinator selections will occur at an greed National Puja being major Collective events. State Councillor selections may occur at an alternative state upon the Collective's request. Selections will be managed by the Facilitators.

## **APPENDIX: CRITERIA FOR CANDIDATES**

Nominees for a role of Sahaja Yoga Representatives need to meet the following criteria:

- They are actively involved in the work of Sahaja Yoga
- They regularly attend collective programs and pujas

• Their personal circumstances are such that they can actively contribute to the workings of the administration in a respectful, positive manner always having Her Holiness and the welfare of the collective in the attention and the highest priority.

- They agree to always adhere to HH Shri Mataji's advice and instructions.
- They should enjoy the general respect of the Collective.
- They have no pending legal action that may bring Sahaja Yoga into disrepute.

• Any nominee who has a criminal record which would affect their ability to carry out their role as a Representative should decline to be nominated.

• Any Representative involved in legal action (not considered malicious in nature) must step down from their position until the matter is resolved. A replacement for the position can be arranged if the situation is long term.

• Representative who resigned during their term of service will not be eligible to be considered unless they provide a legitimate reason such as a required employment relocation to another state

• Anyone in a position where they can't provide or prove the existence of their Selection records involving either or both the Stage 1 and Stage 2 process with a signed and dated Results Form will be considered invalid.

• It is recommended that only one yogi from a single family be selected and act as a representative as having more than may impact upon the family.

• All nominees must provide digital or photographic proof of a current Working With Children Check clearance (or equivalent in other States) with their application to be considered for Selection.

• All nominees' names will be recorded and applications meeting the criteria will be offered to HH Shri Mataji via the Vibration Selection process.
